BOOKING & DEPOSIT GUIDELINES.- In order to secure your date, a deposit and signed contract uploaded to www.chefmikesrq.com are required. Once both of items have been received, your booking is confirmed. A \$200 deposit is required for all events totaling \$799 or less, and a 25% deposit is required for all events above \$800. **Deposits are non-refundable** and are applied to your total bill as a down payment. In the event of a cancelation, your deposit is forfeited. Payment is based upon quoted price without exception of guest attendance. Remaining balance will be due upon date of booked event by or before the end of the evening. If you need to reduce guest count, this must take place 2 weeks prior to event date and be confirmed. Adding to guest count can be done up to 48 hours prior to the event. Pricing will be adjusted accordingly once authorized
